Annexure - B

Terms & Conditions

The bidder is required to *agree* on the following terms and conditions for the successful submission of bid

1. **Technical specifications:** The vendor will fabricate the components as per the material specification and drawings provided by IUAC. Each component mentioned in the Annexure I has a separate drawing. The drawings are proprietary in nature, hence the drawings will be shared after receiving the email request to Dr. Soumen kar (kar.soumen@gmail.com) for preparing the technical and financial bids. A confidentiality certificate needs to be submitted before availing the drawings. The successful bidder need to prepare the fabrication drawing if necessary.

2. **Material test certificate :** The vendor will provide a material test certificate before the fabrication of the components

3. **Tender Procedure & other details**

The bidder(s) will have to submit the tender document as per the following instructions. This is a two-part tender ; Part I -Techno-Commercial & Part II- Price-Bid.

I. Tenders should be submitted in sealed envelopes in two parts separately in the following manner :

A. Envelope No. 1 (Technical Bid): It should contain

- Entire NIT document (except the price bid part) duly signed & stamped as a token of acceptance to the NIT conditions
- Earnest Money Deposit (EMD) if any
- Technical documents (as mentioned in **section-**)

The envelope must be sealed and super-scribed with the following information:

- Tender Reference Number i.e. NIT No.
- Due Date of opening
- Name of the Bidder

B. Envelope No.2 (Price Bid): It should contain

- Price only as per prescribed format.

The envelope must be sealed and super-scribed with the following information:

- Tender Reference Number i.e. NIT No.
- Due Date of opening
- Name of the Bidder

C. Both the sealed envelopes should further be sealed in a single envelope super-scribing Notice Inviting Tender (NIT) No. with Name of work, due date for opening, bidders name & address. The tender duly filled need to be sent to above mentioned address either by post/Courier or hand delivered in the Tender Box kept in the area near west side entrance of IUAC, after ensuring that due entries are made in the register kept at the counter. It should not be handed over to any employee of the centre. No tender shall be accepted later than the time schedule specified above.

After opening of the technical bids, the bidder(s) will have to clarify all the queries, if any, asked to them within specified time limit as decided by IUAC.

4. **Quotation currency:** Price of the item should be quoted in Indian National Rupee (INR) only. Freight and Packing Charges, if any, should be provided along with the quotation.
5. **Validity of quotation:** The period of validity of quotation should not be less than **30** days.
6. **Delivery period:** The goods have to be delivered at IUAC within **50** days from the date of Purchase Order.
7. **Earnest Money Deposit:** EMD of amount ₹ 18000 needs to be submitted along with the bid document in the form of a Demand Draft in favour of IUAC, Delhi. Bid Security shall be refunded to the unsuccessful bidders on award of contract and to successful bidders on receipt of Performance Security.
EMD is the mandatory requirement, however the MSMEs / NSIC registered with Government Agencies are exempted from payment of Earnest Money Deposit (EMD) and are required to submit Bid Security Declaration form subject to conditions given below: -
 - (a) MSMEs participating in the tender must submit valid & authorized copy of certificate of registration. The MSME's Bidder to note and ensure that nature of services and goods / items manufactured mentioned in MSME's certificate matches with the nature of the services and goods / items to be supplied as per Tender.
 - (b) The registration certificate issued by agencies must be valid as on Bid closing date of the tender. Bidder shall ensure validity of registration certificate in case bid closing date is extended.
 - (c) The MSMEs who have applied for registration or renewal of registration with any of the authorized agencies / bodies but have not obtained the valid certificate as on close date of the tender, are not eligible for exemption / preference.
8. **Warranty and after sale service:** **One year** warranty period for the manufacturing defects for all components from the date of delivery of the components at IUAC. Any manufacturing reacted failure in this period should be attended by the vendor free of cost within two weeks of period of reporting.
9. **Performance Security:** Bidder will have to submit Performance Security for an amount which is 5% of the order value, valid up to two (02) months beyond the warranty period, within 15 days on issue of Purchase Order in the form of irrevocable bank guarantee or FDR.

10. **Inspection and Test**

Inspection will be done at the manufacturing site of the vendor before shipment of Goods at IUAC. If necessary, IUAC personnel will take samples of the material for doing materials testing independently

11. **Payment terms:** 100% payment after successful testing and acceptance by the user subject to submission of Performance Security. Bank details should be provided with the quotation for electronic payment to the successful bidder. Payment will be released

on complete delivery of goods at IUAC and its certification by the personnel concerned. Payment may be rejected if quality of goods is found unsatisfactory.

12. **GST:** Extra as applicable.
13. **Liquidated Damages (Late Delivery) :** In case supply is delayed beyond the specified delivery date, deductions on account of liquidate damage @0.5% per week or thereof will be deducted subjected to maximum of 10% of order value.
14. **Force Majeure :** The right of the contractor/supplier to proceed with the work shall not be terminated because of any delay in the completion of the work due to unforeseeable causes beyond the control and without the fault or negligence of the contractor/supplier, including not limited to acts of God, Pandemic, or of the public enemy, restraints of a sovereign state, firms, wars, fires, epidemics, quarantine restrictions, floods, unusually severe weather. If a Force Majeure situation arises, the supplier/contractor shall promptly notify along with the justification / reasons well in advance to the Director IUAC for approval without any prejudice to price escalation. No time extension request shall be considered after the expiry of completion period/contract. **The decision of the IUAC Director will be final and binding on the bidder/ supplier / contractor.**
15. IUAC reserves the right to reject one/ all the bids or cancel the tender without assigning any reasons thereof.
16. **Preference to make in India:** It is mandatory for bidders to quote items having local content minimum 20%. Refer revised Public Procurement (Preference to Make in India), Order 2017, No. P-45021/2/2017-PP (B.EII) dated 16.09.2020 issued by DPIIT, Ministry of Commerce and Industry, Govt. of India as notified from time to time. (Submit duly filled Declaration of Content as per Annexure G). The Declaration of Content once submitted in the Technical Bid will be final. Submission of Revised Declaration of Content will NOT be accepted. As per O.M. of DPIIT, Ministry of Commerce and Industry, Govt. of India No. P-45021/102/2019- BE-II- Part (1) (E-50310) Dated 04.03.2021, Bidders offering Imported products will fall under the category of Non-Local Suppliers. They cannot claim themselves as Class-I or Class-II Local Suppliers by claiming the services such as Transportation, Insurance, Installation, Commissioning, Training and After Sale Service Support like AMC/ CMC etc. as Local Value Addition.
17. Copy of work orders and successful completion certificate/Installation report for similar scientific equipment delivery successfully executed for Govt department/ Govt. Autonomous Body / PSU/educational institutions in India during the last 5 years ending last day of month previous to the one in which applications are invited in the following manner:
 - Three similar completed works costing not less than the amount equal to 40% of the estimated cost.

Or
 - Two similar completed works costing not less than the amount equal to 50% of the estimated cost.

Or

- One similar completed work costing not less than the amount equal to 80% of the estimated cost.

Any work order or purchase order with concealed, undisclosed or misinterpreted values, specifications will not be considered.

18. No deviation from the stipulated terms and conditions will be allowed. Tender will be unconditional.

19. Any dispute arising out of this tender will be subjected to jurisdiction of New Delhi / Delhi only.
