General Terms & Conditions

The bidder is required to *agree* on the following terms and conditions for successful submission of bid

1. **Submission of Quotation:** Quotations should be submitted in sealed envelopes in super scribing indent no 1123 & name of work, due date for opening, bidder's name & address. The quotation duly filled in may be sent to above mentioned address either by post or hand delivered in the quotation box kept in the area near west side entrance, after ensuring that due entries are made in the register kept at the counter. It should not be handed over to any employee of the centre. No quotation shall be accepted later than the time schedule specified above. IUAC will not be responsible for quotation lost in postal transit or otherwise

Last date for submission of quotation 30-Dec-2025 at 3.00 pm.

- 2. **Technical specifications :** The bidder should agree on the technical specifications / scope of works as mentioned in tender and provide mandatorily all the documents as below:

IUAC reserves the right to inspect the sites/work places where they have executed similar works successfully.

- 3. **OEM** / **authorized distributor** (**Not Applicable**) : The bidder should either be OEM or authorized distributor / Bid specific authorisation of OEM only. In case of distributor, authorization certificate from OEM should be provided along with the quotation.
- 4. **Quotation currency**: Price of the item should be quoted in Indian National Rupee (INR) only. Freight and Packing Charges, if any, should be provided along with the quotation.

5. **Prices:** In this bid the vendor is required to quote his items rates/ prices for the items/works after taking into accounts the scope of work & technical specifications. The rates/price should be inclusive of all the material cost, labour, services, charges for the plant/machinery/tools & tackles required for work, testing, commissioning, freight, loading/unloading, Insurance, Octroi, Govt. duties, taxes, service tax, work contract tax etc. (except GST) up to IUAC site basis. However GST should be quoted extra.

Rates quoted shall be firm and valid till the completion of work. No charges towards quantity variations (except item rates), escalation, site difficulties, other hidden item / work cost even though they may not have been explicitly mentioned in the scope and schedule of works but required for completion of project, shall be payable extra or separately. It is mandatory on vendor to quote all items rate as asked for in the BOQ/PRICE schedule. Failure to adhere to this condition will lead to rejection of quotation. The vendors should quote unconditional rates, neatly written without any overwriting, white fluid, erasing etc. and duly signed & stamped on all pages.

- 6. **Validity** Quotation shall be valid for our acceptance without any change in rates and NIT conditions for a period of 90 days from the date of opening of price bid.
- 7. **Escalation:** No escalation over and above items rates quoted by the vendor shall be paid till the completion of work under any circumstance.
- **8. Completion time:** The time shall be the essence of this contract and entire work as titled above is to be completed in all respects within a period of three months of issue of LOI / PO. However any delay in completion of the work for reasons attributable to the contractor is liable for liquidated damages as per NIT clause. Under the force major conditions or delay due to reasons beyond control of the contractor, IUAC may grant suitable time extension for which the contractor has to request along with the justification/reasons well in advance to the Director IUAC for approval without any prejudice to price escalation. No time extension request shall be considered after the expiry of completion period/contract. The decision of the Director will be final and binding on the vendor/contractor.
- 9. **Earnest Money Deposit:** EMD Rs 20000 (Rupees Twenty Thousand only) is to be submitted along with the bid document in the form of Demand Draft / Banker's Cheque in favour of IUAC, Delhi. Bid Security shall be refunded to the un-successful bidders on award of contract and to successful bidders on receipt of Performance Security.
- EMD is the mandatory requirement, however the MSMEs /NSIC registered with Government Agencies are exempted from payment of Earnest Money Deposit (EMD) and are required to submit Bid Security Declaration formsubject to conditions given below: -
- (a) MSMEs participating in the tender must submit valid & authorized copy of certificate of registration. The MSME's Bidder to note and ensure that nature of services and goods / items manufactured mentioned in MSME's certificate matches with the nature of the services and goods / items to be supplied as per Tender.
 - 10. (b) The registration certificate issued by agencies must be valid as on Bid closing date of the tender. Bidder shall ensure validity of registration certificate in case bid closing date is extended.

- 11. **Performance Security**: Successful Bidder will have to submit performance bank guarantee of amount Rs.50000 (Rupees Fifty Thousand only) in favour of INTER-UNIVERSITY ACCELERATOR CENTRE. At New Delhi. Performance Security may be furnished in the form of Insurance Surety Bond, Account Payee Demand Draft, Fixed Deposit, Receipt from a Commercial bank, Bank Guarantee (including e-Bank Guarantee) from a Commercial bank or online payment in an acceptable form safeguarding the purchaser's interest in all respects. Performance Security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations
- 12. **Payment terms**: 100% payment will made after submission of bill after completion of works and handing over of the required certificates.
- 13. **Deviations:** No deviation from the stipulated terms and conditions will be acceptable. Ouotation should be unconditional.
- 14. **Site Conditions**: Contractor shall acquaint himself fully with the site conditions and the working environment of IUAC before quoting his rates. No Compensation on account of any site difficulties will be entertained, at a later date, after award of the works.
- 15. **Liquidated Damages** (**Late Delivery**): In case the work is delayed beyond the specified completion period for reasons at attributable to the contractor, deductions on account of liquidated damages @ 1% of the contract value per week will be deducted subject to a maximum of 10% of the total cost. However, in case the works are delayed beyond the scheduled completion/ contract period, IUAC reserves the right to get the work done by any other contractor at the risk and cost of the contractor and the amount along with 15% overhead to the affect will be deductible from his bills/dues.
- 16. **Labour Laws:** The contractor will abide by all the rules and regulations related to labour laws, accident, workmen compensation act, workmen insurance, ESI, EPF, etc. This will be the sole responsibility of the contractor. IUAC will not be a party at any stage in any of the disputes relating to the above. In case any liability arises due to non-conformance by the contractor, under no circumstances IUAC will be liable for the same.
- 17. **Rules Governing the Contractor's Employees working in the IUAC Premises**:

 The contractor's employees working inside the IUAC campus will abide by the IUAC conditions. Any damage to the IUAC property due to mishandling, carelessness on the
- 18. **Specifications**: Where not specified will be as per the best industry practices, ISI marked or CPWD Technical Specifications, However decision of IUAC engineer will be final.

contractor's or his workman's part will be recoverable from the contractor's bills.

19. **Force Majeure :**The right of the contractor/supplier to proceed with the work shall not be terminated because of any delay in the completion of the work due to unforeseeable causes beyond the control and without the fault or negligence of the contractor/supplier, including not limited to acts of God, Pandemic, or of the public enemy, restraints of a sovereign state, firms, wars, fires, epidemics, quarantine restrictions, floods, unusually severe weather. If a Force Majeure situation arises, the supplier/contractor shall promptly notify along with the justification / reasons well in advance to the Director IUAC for approval without any

prejudice to price escalation. No time extension request shall be considered after the expiry of completion period/contract. The decision of the IUAC Director will be final and binding on the supplier / contractor.

- 20. Short fall of documents, if any, in the bid may obtained by the IUAC on email.
- 21. Director, IUAC reserves the right to accept / reject any / all tenders in part / full without assigning any reason whatsoever and the decision of the IUAC in this regard will be binding on all the bidders. IUAC Director also reserves the right to disqualify any bidder and / or cancel the order at any point of time without assigning any reason whatsoever. **The decision of the IUAC Director will be final and binding on the bidder / supplier / contractor.**
- 22. **Correspondence**: All the correspondence in respect of bid / contractual obligation shall be made to "The Administrative Officer (S&P), Inter University Accelerator Centre, Aruna Asaf Ali Marg, New Delhi –110067". E-mail: iuacstores@gmail.com, Telephone: +91-11-24126018, 24126022.
- 23. The contract shall be governed by the Indian Laws. Any dispute arising out of this contract will be subjected to jurisdiction of New Delhi / Delhi only.
- 24. **Subletting:** The contract shall not be assigned or sublet without the written approval of the IUAC.
- 25. Contractor should depute a qualified supervisor dedicated for this site, who will coordinate work execution activities and interact with the IUAC representative responsible for supervision of work. Without a supervisor work will not be allowed.
- 26. All the persons deployed by the vendor at IUAC site will have to carry valid gate passes, which will be only issued after submission of their bio-data in desired format. Any negligence/offense on their part will attract immediate removal from site.
- 27. The contractor will provide for all necessary materials, tools, equipment, measuring instruments and working consumables etc. needed for execution of the works. Safe custody of all such material will be contractor's sole responsibility. No extra charges will be paid for the same.
- 28. Watch and ward of all material till the system is taken over by IUAC shall be the sole responsibility of the contractor and pilferage etc. shall be entirely to his account.
- 29. All the employees will have to be covered under insurance against any personal accident and IUAC will not be liable for payment of any compensation on that account.
- 30. Suitable lighting arrangements will have to be arranged by the Contractor at his own cost. However, IUAC will provide for power/light points at nearest available point from the place of work.
- 31. The work shall be carried out as per the norms set by the manufacturer of respective equipment, specification and specific instructions as may be issued by the IUAC representative responsible for work from time to time.

- 32. During execution of work, the contractor should follow all standard norms of safety measures/precautions to avoid accidents/damages to man, machines and buildings. Non-adherence of this clause, suitable fines, as decided by the Director, IUAC shall be imposed.
- 33. Manpower deployed by the contractor at our site for carrying out contracted works is strictly prohibited being associated with any other works on the campus.
- 34. No material belonging to the contractor whether consumable or non-consumable should be brought inside the IUAC campus without proper entry at the main gate nor any material should be taken out without proper gate pass issued by the centre. List of all inwards/outwards challan to be maintained by the contractor with a copy mark to IUAC Engineer.
- 35. IUAC will provide free water and electricity during installation work at IUAC, at one point. The contractor has to make his own arrangements for installation of power and water from that point as per his requirements.
- 36. Quotation once submitted will remain with the centre and will never be returned to the vendors.
- 37. **Termination of Contract:** The Director, IUAC reserves the right to terminate the contract on account of poor workmanship, failure to mobilise the site within 30 days, non-compliance of set norms/ specifications for the works, delay in progress of work, violation of any contract provisions by the contractor. In such case the contractor is liable to pay liquidated damages @ 5% of quotation value besides security deposit / EMD.
- 38. **Resolution of Dispute:** All disputes arising out of this contract shall be referred to the sole arbitration of a person selected by the contractor out of the panel of three persons nominated by the Director IUAC, and his decision /award shall be final and binding on both parties. The Arbitration shall be governed under the Indian Arbitration Act 1996 or any statutory modifications or re-enactment thereof and rules made there under and for the time being in force shall apply to the arbitration proceeding under this contract. Any dispute arising out of this contract will be subjected to jurisdiction of New Delhi/Delhi.

Scope of Supply and Works:

Introduction:

IUAC intends to get the statutory Non-destructive test (i.e. Ultrasonic thickness, Ultrasonic weld flaw, Hardness, Pneumatic testing and testing of Relief valves) and certification as per under SMPV Rule -19, of 05 nos, 150 $\rm m^3$ each, horizontal type, cylindrical with dish ends SF₆ Storage Tanks installed out door in IUAC campus, New Delhi.

The Bullets are filled **with SF₆gas**. The same will be transferred by IUAC in other Bullets simultaneously and vented to atmosphere pressure with compressed air using compressor, and vacuum pump etc. as and when required.

Followings are deemed to be included in vendor's scope in quoted rates:

- a) To carry out the statutory Non-destructive tests (i.e. visual surface inspection, ultrasonic thickness, ultrasonic weld flaw, hardness, pneumatic testing, Relief valve) and certification as per under SMPV (U) Rule -18, 19 (1981, 2016), of 05 nos, 150 m³each, horizontal type SF₆ Storage Tanks installed out door in IUAC campus, New Delhi.
- b) Arrangement by vendor for the tools, tackles, material, instruments, manpower, expertise, scaffolding, ladders etc. required to carry out the work.
- c) It is emphasized that the bidders should visit the site before quoting the prices in order to acquaint with the site conditions and work volume.
- d) Dismantle of all the flanges i.e. drain ports, gas inlet / outlet port, RV port, man holes etc. by loosening of nuts and bolts. bidder to note that the nuts, bolts may be rusted

- and threads filled with the paint etc. Rustolene /WD-40 etc. will be required and shall be supplied by vendor to clean the same before loosening the same.
- e) Immersing of all the nuts and bolts in the rustolene or equivalent cleaning chemical for minimum 24 hours for cleaning of the same from rust. Cleaning of the threads with wire brushes and cloth.
- f) Removing of old O-Rings from the flange grooves, cleaning of flanges, flange grooves and surfaces with sand stone and rustolene etc. Painting of the same.
- g) Supply and fixing of new O-rings(ID-61 mm, OD-79 mm-18 nos, ID-641 mm, OD-659 mm -05nos) of all flanges (Item rates asked in BOQ).
- h) Supply and fixing of new asbestos gaskets of 3 mm thickness as per requirement.
- i) Cleaning of the internal surface of the bullets with warm water after clearing of the foreign material if any, from inside.
- j) Arrangement for the scaffolding, ladders, ropes etc. to carry out the work.
- k) Cleaning of the inside surface from the dust, rust, loose paint peel off, grease etc. using emery paper, cleaning cloth and cleaning agent.
- 1) Carry out the inside surface visual inspection using magnifying glass with inbuilt torch.
- m) Preparing of the surfaces by removing paint etc to carry out the statutory NDT tests and repainting of the same.
- n) Arrangement of instruments, tools etc. and carrying out the statutory NDT tests.
- o) If required, supply and applying of one coat of metal primer on rusted and bare metal surfaces after surface preparations including red oxide primer, turpentine oil, emery paper, brush, cleaning cloth etc. (Item Rate asked in BOQ)
- p) If required, supply and applying of two coats of Aluminum paint on whole inside surface of the bullets after surface cleaning including Aluminum paint, turpentine oil, brush, emery paper, cleaning cloth etc. (Item rate asked in BOQ)
- q) Dismantling of spool pieces, butterfly valve,rupture disc assembly, relief valves and refixing of same with new gaskets in position after cleaning of all. The relief valves shall be tested by vendor on the designed pop up pressure with dry nitrogen test set up offline. The relief valves spring loaded type shall be dismantled, each part cleaned, assembled and adjusted to designed pop up pressure before re-fixing.
- r) Supply and fixing of Rupture discs as per requirement.
- s) Fixing of all the flanges by tightening of the nuts and bolts. Silicon grease shall be supplied and applied on all the O-rings/gaskets for pressure / vacuum leak proof.

- t) Pressuring the tanks with compressed air upto 11.13 kg/cm²(1.25 times the design pressure) for pressure test. IUAC will supply the compressed air from it's plant to pressurise the tanks upto11.13 kg/cm².
- u) Leak test with soap bubble test of all the flange joints shall be done. If any leak is found vendor will have to repeat the process of filling compressed air after leak rectification, till the leak proof joint is observed, without any extra cost to IUAC.
- v) All the tests, certification and issue of reports shall be carried out as per UNDER SMPV
 (U) RULE -18,19 and other relevant applicable laws as per the requirements of the PESO for renewal of the license.
- w) Final payment will only be made against the actual quantities installed and not on the basis of items supplied / BOQ. For this a joint measurement by IUAC engineer and the contractor will have to be taken. The responsibility and the facilitation for taking the measurements will rest with the contractor.
