Terms & Conditions

The bidder is required to **agree** on the following terms and conditions for successful submission of bid:

- Technical specifications:** The bidder should agree on the technical specifications as mentioned in Annexure-A and provide all the necessary documents supporting the specifications mentioned in the table.
- OEM/ authorized distributor:** The bidder should either be OEM or authorized distributor of OEM only. In case of distributor, **authorization certificate from OEM must be provided** along with the quotation.
- Quotation currency:** Price of the item should be quoted as unit price in Indian National Rupee (INR) only. Freight and Packing Charges, if any, should be provided along with the quotation.

4. **Validity of quotation:** The period of validity of quotation should be clearly mentioned (should not be less than 45 days).
5. **Delivery period:** The delivery of material should be within 90 days from date of purchase order.
6. **Earnest Money Deposit:** EMD @ 2% of total estimated value of the contract is to be submitted along with the bid document in the form of Demand Draft in favour of IUAC, Delhi. Bid Security shall be refunded to the unsuccessful bidders on award of contract and to successful bidders on receipt of Performance Security.
EMD is the mandatory requirement however the MSMEs/NSIC registered with Government Agencies are exempted from payment of Earnest Money Deposit (EMD) and are required to submit Bid Security Declaration form subject to conditions given below: -
 - (a) MSMEs participating in the tender must submit valid & authorized copy of certificate of registration. The MSME's Bidder to note and ensure that nature of services and goods/items manufactured mentioned in MSME's certificate matches with the nature of the services and goods /items to be supplied as per Tender.
 - (b) The registration certificate issued by agencies must be valid as on Bid closing date of the tender. Bidder shall ensure validity of registration certificate in case bid closing date is extended.
 - (c) The MSMEs who have applied for registration or renewal of registration with any of the authorized agencies / bodies but have not obtained the valid certificate as on close date of the tender, are not eligible for exemption / preference.
7. **Warranty and after sale service:** One-year (minimum) warranty period for the Proportional Valve from the date of installation at IUAC. Any damage or repair required in this period should be attended by the vendor free of cost within two weeks of period of reporting. The authorized personnel for servicing/ maintenance etc. should be specified. Vendor should specify the capacity & capability to undertake repair and service works (if available) in India. The parts not covered under the warranty should be clearly mentioned. Extended warranty (up to 5 years) beyond the period of normal warranty period may be quoted. Extra charges, if any, may be quoted separately. During the extended warranty period, the vendor should calibrate the detector every year.
8. **Payment terms:** 100% payment after successful installation, testing and acceptance by the user subject to submission of Performance Bank Guarantee @5% of the order value valid up to two (02) months beyond warranty period. Bank details should be provided with the quotation for electronic payment to the successful bidder.
9. **GST:** Extra as applicable.
10. **Liquidated Damages (Late Delivery):** In case supply is delayed beyond the specified delivery date, deductions on account of liquidate damage @ 0.5% per week or thereof will be deducted subjected to maximum of 10% of order value.
11. **Force Majeure:** The right of the contractor/supplier to proceed with the work shall not be terminated because of any delay in the completion of the work due to unforeseeable causes beyond the control and without the fault or negligence of the contractor/supplier, including not limited to acts of God, Pandemic, or of the public enemy, restraints of a sovereign state, firms, wars, fires, epidemics, quarantine restrictions, floods, unusually severe weather. If a Force Majeure situation arises, the supplier/contractor shall promptly notify along with the justification/reasons well in advance to the Director IUAC for approval without any prejudice to price escalation. No time extension request shall be considered after the expiry of completion

period/contract. The decision of the IUAC, Director will be final and binding on the supplier/contractor.

12. **Preference to make in India:** It is mandatory for bidders to quote items having local content minimum 20%. Refer revised Public Procurement (Preference to Make in India), Order 2017, No. P-45021/2/2017-PP (B.EII) dated 16.09.2020 issued by DPIIT, Ministry of Commerce and Industry, Govt. of India as notified from time to time. (Submit duly filled Declaration of Content as per Annexure G). The Declaration of Content once submitted in the Technical Bid will be final. Submission of Revised Declaration of Content will NOT be accepted.

As per O.M. of DPIIT, Ministry of Commerce and Industry, Govt. of India No. P-45021/102/2019- BE-II- Part (1) (E-50310) Dated 04.03.2021, Bidders offering Imported products will fall under the category of Non-Local Suppliers. They cannot claim themselves as Class-I or Class-II Local Suppliers by claiming the services such as Transportation, Insurance, Installation, Commissioning, Training and After Sale Service Support like AMC/ CMC etc. as Local Value Addition. **THIS CLAUSE IS NOT APPLICABLE FOR THIS ITEM.**

13. Proof of delivery of high-end scientific/electronic equipment in the form of one copy of successfully executed purchase order value more than 80% of the estimated value or two copies of order value each of 50% of the estimated value or three copies of order value each of 40% of the estimated value for the supply of similar kind of items to reputed organizations, Govt. Dept.(Central/State), PSU & Autonomous bodies/Universities in India in the last 3 years.
