### **ANNEXURE-B: Terms & Conditions**

The bidder is required to *agree* on the following terms and conditions for successful submission of bid:

#### 1. Pre-Bid qualification:

- i. The quoted item should be a standard catalogue product, displayed prominently in product catalogue / OEM website.
- ii. Authorized Distribution certificate with authorization from the OEM/ undertaking on letter head about authorized distributorship for the tendered items in India from OEM of detector assembly should be uploaded.
- iii. Drawings/ test results/catalogues/other technical specifications of the products indicating its ability to meet the technical specifications.
- iv. One copy of purchase order value more than 80% of the tender value or two copies of order value more than 50% of the tender value or three copies of order value more than 40% of the tender value for the supply of scientific instruments to reputed organizations, Govt. dept., Public sector & Autonomous bodies in India in the last 3 years.
- v. Copies previous three years Income Tax Return (ITR) and Self attested copies of GST Registration and PAN number
- vi. Average annual turnover during the last three financial years ending 31st March, 2024 [2021-22 & 2022-23& 2023-24, shall be at least double of the tender value. Duly audited financial statement/balance sheet/certified by CA to be submitted as supporting documents.
- 2. **Technical specifications**: The bidder should agree on the technical specifications as mentioned in Annexure-A, and should provide all the necessary documents supporting the specifications mentioned in the table.
- 3. **Quotation currency:** Price of the item should be quoted as unit price in Indian National Rupee (INR) only. Freight and Packing Charges, if any, should be provided along with the quotation.
- 4. **Validity of quotation:** The rates quoted in the tender shall hold good for 180 days from the date of opening of the price bid of the tender. The validity of the rates is extendable for a period of 180 days from the date of issue of award letter with mutual consent of both the parties. No tenderer on his own withdraws or revokes the tender or revises or alters or modifies the tender for any item or condition within a period of aforesaid period of 180 days. No escalation of cost will be acceptable in any condition after opening of tender.
- 5. **Earnest Money Deposit:** The Earnest Money Deposit for Rs. 32000/- should be deposited before the bid opening. Bid Security shall be refunded to the un-successful bidders on award of contract and to successful bidders on receipt of Performance Security.
  - EMD is the mandatory requirement however the MSMEs/NSIC registered with Government Agencies are exempted from payment of Earnest Money Deposit (EMD) subject to conditions given below: -
  - i. MSMEs participating in the tender must submit valid & authorized copy of certificate of registration. The MSME's Bidder to note and ensure that nature of services and goods/items manufactured mentioned in MSME's certificate matches with the nature of the services and goods /items to be supplied as per Tender.

- ii. The registration certificate issued by agencies must be valid as on Bid closing date of the tender. Bidder shall ensure validity of registration certificate in case bid closing date is extended.
- iii. The MSMEs who have applied for registration or renewal of registration with any of the authorized agencies / bodies, but have not obtained the valid certificate as on close date of the tender, are not eligible for exemption / preference.
- 6. **Delivery period:** The delivery of material should be within 45 days from date of purchase order.
- 7. **Warranty and after sale service:** 3-year (minimum) warranty period for the components from the date of installation at IUAC. Any damage or repair required in this period should be attended by the vendor free of cost within two weeks of period of reporting and replacement of the items should be initiated.
- 8. **Payment terms:** 90% of the payment shall be made within 30 days from the date of the delivery of the goods at IUAC after inspection, testing and acceptance of the equipment at IUAC in good condition and to the entire satisfaction of the concerned IUAC personnel. Balance 10% payment can be released in exchange of fresh performance security deposit to be valid up to 60 days beyond the guarantee period/Defect Liability period, which is 10% of the value of contract. The payment process will be initiated on submission of the bills by the bidder and after due certification by the concerned IUAC personnel. All payments will be made after statutory deductions.
- 9. **Performance Security: -** The supplier shall require to submit the Performance Security within 15 days on issue of Purchase Order in the form of irrevocable bank guarantee or FDR issued by any Indian Nationalized Bank for an amount which is 3% of the order value and should be kept beyond the delivery period. The Performance Security shall be refunded to the supplier after the due certification by IUAC personnel.
- 10. **GST:** Extra as applicable.
- 11. **Declaration of Local content:** The bidder should qualify for the requirement of minimum local content to quote as ingenious supplier according to GFR rule. The bidder should declare the local content percentage clearly as per Annexure C.
- 12. **Liquidated Damages** (**Late Delivery**): In case supply is delayed beyond the specified delivery date, deductions on account of liquidate damage @1% per week or thereof will be deducted subjected to maximum of 10% of order value.
- 13. **Force Majeure:** The right of the contractor/supplier to proceed with the work shall not be terminated because of any delay in the completion of the work due to unforeseeable causes beyond the control and without the fault or negligence of the contractor/supplier, including not limited to acts of God, Pandemic, or of the public enemy, restraints of a sovereign state, firms, wars, fires, epidemics, quarantine restrictions, floods, unusually severe weather. If a Force Majeure situation arises, the supplier/contractor shall promptly notify along with the justification/reasons well in advance to the Director IUAC for approval without any prejudice to price escalation. No time extension request shall be considered after the expiry of completion period/contract. The decision of the IUAC, Director will be final and binding on the supplier/contractor.

#### 14. Clarification of Bids and shortfall documents

- (a) During the evaluation of Techno commercial or Financial Bids, Indentor on behalf of IUAC may, at its discretion, but without any obligation to do so, ask Bidder to clarify its bid by a specified date. Bidder should answer the clarification within that specified date (or, if not specified, 7 days from the date of receipt of such request). The request for clarification shall be submitted in writing or electronically and no change in prices or substance of the bid shall be sought, offered or permitted that may grant any undue advantage to such bidder.
- (b) IUAC reserves its right to, but without any obligation to do so, to seek any shortfall information/documents only in case of historical documents which pre-existed at the time of the tender opening, and which have not undergone changes since then and does not grant any undue advantage to any bidder.

#### 15. **Tender Rejection**:

- i. IUAC reserves the right to accept/reject any/all tenders in part/full without assigning any reason whatsoever and the decision of the IUAC in this regard will be binding on all the bidders. Director, IUAC reserves the right to accept or reject any tender without assigning any reason and does not bind himself to accept the lowest tender.
- ii. Bids received by means other than e procurement portal will be rejected.
- iii. Complete bids will be considered. Bids of some part of the product will be rejected.
- iv. Tenders not complying with any of the provisions stated in this tender document are liable to be rejected.
- v. If the General Terms and conditions are not accepted and not signed by the bidders, then the tender will be rejected.
- vi. The contract shall be governed by the Indian Laws. Any dispute arising out of this contract will be subjected to jurisdiction of New Delhi / Delhi
