ENGAGEMENT OF CONTRACTUAL MEDICAL CONSULTANT ON FIXED TENURE BASIS

Inter University Accelerator Centre (IUAC), New Delhi, an Autonomous Centre of University Grants Commission under Ministry of Education, Govt. of India, invites applications from eligible candidates for the position of Part-Time Medical Consultant (MC) on purely contract basis initially for a period of one (01) year which can be extended on the basis of performance for the In-house clinic as per details given below:

Sr. No.	Item	Terms & Conditions
1	Basic Qualification	General Medicine M.B.B.S. from recognized Indian Institution with at least 5 years of experience as a Registered (MCI/NMC/DMC etc.) Medical Practitioner. Desirable – M.D. in General Medicine (P.G. Qualification recognized by MCI/NMC) with at least three years' post qualification experience. Preference shall be given to the Doctors residing in nearby areas of IUAC.
2	Age	Preferably below 50 years.
3	Working Hours	Monday to Saturday from 04:00 PM to 06:00 PM (Except 2 nd & 4 th Saturday and Gazetted Holidays)
4	Terms of Contract	Initially, the appointment shall be for a period of three years which may be extended further on the basis of performance. The engagement of Medical Consultant shall be purely on contractual basis and will not confer any right for regular appointment in the Centre.
5	Termination of Contract	The contract can be terminated by one month's notice on either side at any time during the subsistence of the period of contract.
6	Consolidated Remuneration	<ul style="list-style-type: none">a. The consolidated fees of Doctor with M.B.B.S. will be Rs. 45,000/- per month (Inclusive of Petrol/Conveyance expenses).b. The consolidated fees of Doctor with M.D. (Medicine) will be Rs. 50,000/- per month (Inclusive of Petrol/Conveyance expenses). <ul style="list-style-type: none">➤ Centre will not pay any type of other fee/charges/allowances other than consolidated fee as mentioned above.➤ Taxes will be deducted as per applicable statutory provisions.

7	Procedure for Selection	Applications received will be scrutinized and eligible candidates shall be called for personal interview. The date, time and venue of the Personal Interview will be intimated in advance to the shortlisted candidates.
8	Roles and Responsibilities	<ul style="list-style-type: none"> a. To provide medical consultation to IUAC employees, and Pensioners their dependents, IUAC visitors, Research Associates, students etc. b. Scrutiny of medical bills and verification of essentiality certificate for reimbursement of medical expenditure to the employees of IUAC. c. To administer vaccination as and when required. d. Management of IUAC clinic. e. Any other medical exigencies assigned by the Competent Authority.
9	Other Conditions	<p>Part-time Medical Consultants shall not be eligible for any benefits as available to the employees of the Centre like leave, LTC, Provident Fund, Gratuity or any other terminal benefits, Bonus, Reimbursement of Medical Expenses, Brief Case, Newspaper etc.</p> <p>Part-time Medical Consultants will have to make their own arrangements for providing substitute during their absence, at their own cost, failing which remuneration will be deducted on Pro-rata basis for the period of absence.</p>

How to Apply	<p>Interested eligible Doctors may send their CV along with the self-attested copies of qualification/experience certificates by email at recruitment.iuac@gmail.com so as to reach the Centre on or before <u>20th January, 2026</u> (up to 23:59 hrs.).</p> <p>No TA/DA shall be payable to attend the Interview.</p> <p>Original documents along with self-attested Photocopies of the same shall be brought by the candidates in support of eligibility at the time of interview for verification.</p> <p>Applications received after the due date shall be summarily rejected.</p> <p>Addendum/Corrigendum/Updates, if any, will be available only on the website of IUAC.</p> <p>All the communications with the applicants related to this Advt. will be made through e-mail only.</p>
